GENERAL UPDATES & INFO.

Paul Forman/3838 Atlantic Avenue

Katie and I followed up with Paul Forman last week. We checked out the work he had done to his property and it really has made the building more attractive. It is ideal for a design, advertising, or other creative type of business. We discussed the challenges and will be reaching out to Bank of America to see if an after-hours parking arrangement can be made. If the BKBIA can bring some things to the table (like security patrols, clean-team, and arrange for a towing company) this may be incentive enough to create an agreement. It would help the 3800 block and the businesses there. It may also make it easier for the zoning changes to Paul's building. Updates to follow.

• The Sameness

We are currently in the middle of a unique phenomenon that's also very frustrating. We have interest from the "same" type of businesses wanting to come and open up in the district. We just met with two guys who own a barber shop in downtown on Pine Avenue. We talked to them about the saturation of barbers and salons in the 4200-4300 block of Atlantic and that their services would do better elsewhere in the district. They insist on opening up in the former bike shop which is just doors away from Esquire Barber Shop and across from Super Cuts (let alone all the salons, too). Speaking of saturation, we have our share of nail salons and a eye lash salon in the pedestrian zone. Apparently, Howard CDM wants to lease out our former office space at 4313 Atlantic to an "eye brow" salon which would be next to the existing nail salon which is across the street from Flirt Last Bar. Plus, there is a nail salon just south of us and of course some of the neighboring hair salons offer these services. And shall we mention ramen? The tentative name for the new restaurant at 4262 Atlantic is "Ramen Guild." Katie and I had a great meeting with this business owner and were very direct and honest about the perception of that location from the community perspective and that taking "ramen" out of the business name would be critical for success. He was very openminded and appreciated our candor. He will check with the ABC about name changes to their liquor license application. The bottom line to all

of this is that I am completely baffled and amazed at the lack of market research and understanding of the neighborhood. Businesses are set up to fail by piling on the same thing over and over again in a neighborhood with no density and which craves variety. (Side note: we need a board member to stay on top of the broker for the former Abrams Clark space for fear of a lease to a business that would be bad news to the neighborhood).

Vacant board positions

We have two vacant positions on the board at the moment; At-Large & LB Blvd. Stephanie Gray recently left Howard CDM. I am not sure if Debbie will come back to fill the position or not. Howard CDM has been on the board for more than a decade. I do not believe we are in a rush to fill the positions until we find members that are willing to be engaged and participate in our programs. I do not want to invest any time into someone that isn't investing back into the association.
