8th District Council Report

• Jonathan reported: EIR for 710 freeway, exploring separate freight corridors, etc. Seeking public comment, public meetings set by Cal Trans for August 31 at Chavez Park; city budget will be released next week. The first study session is on August 1 and budget must be adopted by September 15; Back to School event on August 12, Scherer Park, 10am to 1pm, giving away back packs, health screenings; Cheryl asked about the Land Use Element being brought forward to council.

- a. Treasurer Report: Susan reported that she is working with Blair on the FY '17-'18 budget.
- b. Welcome Kits Completed. Cait discussed the distribution to members. Norm asked about the members directly being updated and if the resident volunteer (Stuart) could help maintain the list again.
- c. Vacant Board Seat Servando reported that Jahaziel Romero had missed all board meetings since January, and per the bylaws Jahaziel would be receiving a letter notifying him that he has been removed from the board.
- d. Continued First Fridays Discussion Blair and Cait reported on the new Rules & Regulations sheet that will be distributed to all members. Cait also discussed the importance of the BKBIA retaining control of the Expo Arts Center on First Fridays and not having any other event use the building that night. Events such as Uptown Village Market operating during First Fridays piggyback on the event and cause conflicts within our mission for the BKBIA and First Fridays. - Security & Code Enforcement Mike reported that there were six burglaries around the district. First
 Fridays in July was much better with the kids coming and being disruptive. CSI only had to deal with
 moving kids along at the end of the night.

Bixby Knolls Business Improvement Association Executive Director Report: August 31, 2017

General updates from around the district:

- **Former Tuttle Cameras space** Ambitious Ales has signed a lease for the Tuttle Space. They will brew-on-site. We will help them through the permitting process and recommend contractors to check out the status of the building.
- Cheese Addiction: Construction has begun and they are still shooting to open up in October. It's important that they do so in order to capture the whole holiday season.
- 4262 The restaurant may be opening up again with the same owner. We are trying to get more details on what the plan is.
- **Niky's Sports** Waiting on city approvals to begin build out. All plans have been approved and work should start in the next few weeks.
- Oil tanks on LB Blvd.— We reached out to the owners of the oil property just south of Phil Trani's to inquire about painting the oil tanks. This would (finally) beautify that stretch of the boulevard which is an eyesore. The issue is a matter of insurance and I have explained that the BKBIA is insured and will insure our artists/contractors. Hoping to get a yes or no any day now.
- **Alex Automotive** 3360 Atlantic Avenue, Just learned that his semi-abandoned property is in escrow. We are looking into who is purchasing the lot and what the plans will be for the business/land.
- West Bistro -- Still no movement on construction of this site. Code Enforcement is
 trying to track down the owner since the torn open roof has it looking like a blighted
 property.
- **Homeless encampments** We have been told that small homeless camps have been found in the back of Island Pacific Market, Chase Bank in the BK Shopping Center, and sometimes behind the patio wall at the 4262. CSI is trying to their best to stay on top of this ever-growing issue.
- New mural for LB Blvd. We had a meeting with artist Jeff Fawley and Martin Howard to discuss having a mural painted on the southern wall of 3745 LB Blvd (where we have our final concert). Pow! Wow! had started a mural there but the artist had to get back to The Netherlands so it was painted over. Jeff Fawley lives on Virginia and Roosevelt, does work for major companies like Hurley, Roxy, and used to work for Quiksilver. The mural will really make that wall pop and add to the vibrancy of the boulevard.
