Bixby Knolls Business Improvement Association Executive Director Report: February 2018

General updates from around the district:

- 4262 Atlantic Avenue Met with the landlord to get an update on the property. Former lease holder is now gone and out of the picture. The lease had expired and the landlord has been fielding offers. He has decided to lease the space to George Mitri, owner of Baba Ghanouj, who wants to put in a Mexican-fusion restaurant with soups and salads. This decision still came after an hour-long meeting with me, George, and the landlord (Bernie) discussion the neighborhood's desire for variety and NO more Mexican restaurants. George's apparent compromise is the addition of fresh salads and soups. I will keep the board posted as things develop at the site.
- **3440 Atlantic** The doctor who owns the property is nearly complete with his total makeover of the property. The interior has been transformed into a modern medical facility for plastic surgery and small procedures. The exterior landscaping is being worked on now by our landscaper and this is one of our RDA projects.
- West Bistro: Kelly Bray reported: "I caught up with Steve the owner of West Bistro and his contractor. They have all the appliances delivered and the kitchen is being set up. They are aiming for final inspections in about three weeks. The parking lot has been cut in two places. The section along the building will be an outdoor patio, the section dug up by the lamp post will be handicap parking.
 - He has had issues with illegal dumping, and people going on his roof and messing with his cameras. He is also having some issues with the city. I gave him your card and told him to call if he needed help or wanted to keep us up to date. I gave him a CSI card and explained that if there were homeless or other issues he can call both CSI and the police. His current camera system is not internet enables so I suggest he look into an upgrade and gave him Mike Mora's card."

Kelly will follow up on the plans for the roof and what exactly will be the food options.

- **Ambitious Ales** I attended a family/friends/investors meeting on site a few weeks agon. The owners have a great team involved with them and are moving ahead per their schedule. Demo work is in full progress now. Their tanks have been delivered. I will keep in touch with them about their build-out and a grand opening date in summer.
- **Liberation Brewing**: Brewing beer on site this week and will soon be planning their "neighborhood nights" to introduce themselves to the community. They will also soon be applying for their patio which will connect them to Patricia's so people can order and bring food over to eat.
- Oil tanks on LB Blvd.— After sitting there for years with no attention the BKBIA had reached out to the owners (in Texas) to paint the tanks. The owners finally gave the green light to check out design renderings. It appears that the lot is now, or soon will be, in escrow to be purchased. Our Plan B is to work with the new owners to do something special on the lot once it has been cleared and cleaned up.
