BKBIA FUTURE AND RDA FUND REPLACEMENT

- a. RDA funds contract ends September 30, 2021
- b. City states funds have already been spent; BKBIA provided financial statements of all RDA deposits and notes to debate this. BKBIA contends that funds are still owed. Economic Development is researching this issue.
 - i. Immediate decrease of Core Services:
 - 1. Security; day & night patrols
 - 2. Power washing sidewalks
 - 3. Landscaper/projects
 - 4. Clean Team
 - ii. Recovery Act Funds will arrive to BKBIA in July 2021; amount TBD, (could be \$114K or more); awaiting word from Economic Development
 - 1. Funds will be deposited into the Operating Account and be used as gap funding for the next 6-12 months.
 - iii. Main issue: BKBIA needs funds to maintain current level of service;
 - 1. Clean & Safe, Events, Marketing & Promotion, Façade Improvements,
 - iv. Also needs funds to maintain staff at current and increased levels:
 - a. Executive Director
 - b. Project Manager
 - c. Content Manager
 - d. Clean Team
 - e. Admin/Special Projects
- c. City responded with options for revenue generation and sustainability
 - 1. Expanding the boundaries of the BID
 - a. Potential of: Wardlow to Orange (85); Carson to Orange (56); San Antonio to Orange (29)
 - i. Total number of new businesses: 170
 - b. First outreach
 - c. Legal requirements
 - d. Weigh the Pros vs. Cons
 - i. $170 \times \$279 = \$47,430$
 - 2. Raising the BID assessment to a level that meets or exceeds the fees for other BIDs in the City and correlates with the services and improvements delivered to businesses
 - a. See attached spreadsheet

3. Implementing a property-based BID that enables commercial property owners to invest their fair share in improving the commercial area
