### **Council Reports:**

Sean Bernhoft (CD7) reported: 76.8% of residents have at least one dose of a vaccine; Bars, distilleries, breweries, wineries will now ask patrons for proof of vaccination before entering; Big issue of dumping at Orange & Carson, former thrift store location, CD7 helping to fix the issue; Foasberg Cleaners had lots of tagging and cracked windows. Most of the tagging is now gone; Hispanic Heritage Month celebrated at the libraries; First Youth Festival set for Houghton Park; Daisy Lane Parade now a mobile vehicle parade on December 11.

Jonathan Kraus (CD8) reported: The redistricting process in happening, individuals can submit proposals to the Commission; Commander Zseibel has a community meeting scheduled via Zoom; Pow! Wow! Long Beach starts next week and will be repairing the mural under the train tracks at Del Amo and Atlantic.

#### **Committee Reports:**

- i. **Security & Code Enforcement Report** Blair covered these issues in the E.D. Report. LBPD provided incident report. CSI continues to patrol in its best capacity to address any/all hot spots and respond to member calls.
- ii. **Project Manager Report** Myra reported: Donor program; Business features (National Black Business Month, Hispanic Heritage Month, retail profiles are up next; Expo rental application needs final board review, African American Cultural Center is now a tenant; updates on Knights of the Round (Turn)Table, Kidical Mass, First Fridays; summary of social media followers (IG 19,991; Facebook 18,963 combined pages; 7,000+ in BK Community Facebook page)
- iii. **Executive Director's Report** Blair reported: BKBIA has begun pursuing new revenue streams per the August board meeting, Commune Communication will assist with member outreach and potential boundary

expansion efforts; PUMA consultants cannot pursue a PBID study due to being overcommitted. Seeking other consultants to help with study; Expo Arts Center application update; Security Patrols, cut in half for the time being due to budgets. Will be restored after bridge funding at "relief" funds are received; Care Closet LB providing Clean Team services during the week and doing a great job; Submitted final RDA invoice to Economic Development for reimbursement, \$70K total; needing additional help in the office and staff has asked Tom Underhill to come in on occasion to help with small tasks, Kelly Bray also assisting where needed; Member outreach remains a priority with daily/weekly emails, pursuing a Bixby Business Breakfast; BKBIA asked for donations from a few businesses for the Brown family whose son had been attacked on a bus by a person experiencing homelessness.

#### b. Old Business – BKBIA Future and RDA funding replacement

i. Follow up status on list of revenue streams to pursue; information was shared during E.D. Report.

#### c. New Business - Filling Vacant Atlantic Avenue Board Position

- i. Anthony presented that a board position was vacated when Mike Mora resigned. The Executive Committee discussed the need to have a restauranteur on the board. Anthony proposed having Bjoern Risse, owner of Wood & Salt Tavern and Rasselbock (and local resident) fill the position. He would be a great resource on the board.
  - 1. Bill Made a motion to have Bjoern Risse appointed to the board and fill the vacant Atlantic Avenue position.
  - 2. Aaron seconded the motion.
