• Public Comment

- No public comment was given.
- Appointment of Vacant Board Position Starr Bunch, Long Beach Blvd.
 - O Anthony reported that Brian Savala had resigned from the board leaving a position open on LB Blvd. Anthony recommended the appointment of Starr Bunch, Five Starr Pilates, to fill the position; she has been active with the BKBIA and has been willing to serve on the board for some time. Crystal made the motion to appoint Starr to the board; Servando seconded the motion. Motion passed unanimously.

Council Reports:

• Council District 5: Holly reported that CD5 attended First Fridays and it was a great experience. They plan to attend each month with a table to meet the community; Business support grants are becoming available; CD5 is working with Public Works on traffic studies and plans for Atlantic Avenue and other corridors

Committee Reports:

- i. Project Manager Report Myra reported about promoting the membership through social media; Sal's Gumbo Shack had its grand opening; Taste of Steelcraft event was a success; Working on Valentine's Day promotions; First Fridays Lite on February 4 is coming together; Knights will meet at The Pan tonight. In March, we are working on Almost St. Patrick's Day event (fundraiser event for BKBIA) and our Women of Bixby Knolls features.
- ii. Security & Code Enforcement Included in E.D. Report
- iii. Executive Director Report Blair reported: Pursuing revenue streams with the help of Commune Communication, Commune will send over the second draft of two collateral materials for review; COBA met with the city managers, very productive. Discussion included response times from departments. We will receive an updated list of direct contacts to departments; John Keisler is leaving the city, huge void for Economic Development; Security issues: LBPD saw an uptick in burglary and larceny, LBPD encourages all businesses to invest in lighting and security cameras; CSI make contact with homeless, have been busy with calls from BKBIA members; members need to have first contact with individuals before calling CSI or police for assistance.
- **b.** Old Business: 2nd review of collateral materials from Communication
 - i. Expansion outreach piece no comments or changes
 - ii. Assessment increase piece Discussion ensued from board; compare our assessment fee to other districts, our district is cleaner than most; other areas are not doing what we are doing; Focus the piece on CSI and the security benefit; remove the repeating of the BKBIA mission; change the new fee to \$520 (\$10 a week); keep the piece short and sweet with important info
- c. **New Business:** Review Recovery Act scope of work and budget
 - i. Blair discussed the information shared with the board and the application submitted to the city. Funds are used to help businesses greatly affected most by the pandemic as well as an equitable distribution of the funds.
 Economic Development will provide feedback on the application/scope of work before final submittal for funds.

• Shout out to Kevin, our Clean Team – He is doing an excellent job for us and we thank Care Closet LBC for the connection

• COBA meeting with city managers

• Have a new list of direct contacts for departments to ensure we get the response we are looking for from city staff.

• Business Roundtable with Mayor Garcia

- Attended the CD5 roundtable on Monday and discussed life through and after the closures of the pandemic.
- Happy to have Bjoern, Starr, Jason Van Fleet (Dutch's) and Rabi (Taboon) representing Bixby Knolls at the meeting.

• Recovery Act Grants

- The federal grants are now available, and the application Information has been shared with our membership
- Our Scope of Work had been submitted and was returned with comments from Economic Development. We will finish providing some missing data the city is looking for and then resubmit.

• Bridge Funding

- We have been approved by Eric Romero for the first \$50,000 advance towards these funds
- o Funds will cover all costs from Commune Communication, printing and mailing of collateral pieces, Tom Underhill's time for his work along Orange Avenue and Wardlow, and to pay the grant writer Tom Peters for his time in pursuing grants (first one due in April)
- o We will also use some of the advance for Admin expenses

• Security/Safety Issues:

- o Met with CSI to discuss recent incidents and status in the district:
 - More calls coming from members, all areas of the district
 - Handling it as best as possible given the budget constraints of the BKBIA
 - CSI dealing with similar staffing issues; hard getting new employees
 - CSI is working with the BKBIA on invoices and payments
 - Staff is directed to make patrols around the district as they come and go to a shift
 - CSI was at Kidical Mass last weekend and successfully kept the group safe
- o Cat Shelter status seems to have been cleared out now

• Misc. Notes

 Still trying to find the date, and actual time, to plan the Annual Meeting. Looking to April to get this scheduled.
