#### **Council Reports:**

• Council District 5: Holly reported—First Fridays was very successful for the council office's participation in meeting the community; Holly toured the new Able Arts WORK space at 3841 Atlantic Avenue; CD5 will be setting up a Small Business Roundtable so the Councilmember Mungo Flanagan can meet with business owners and discuss all issues. Crystal brought up the issue of cars speeding around all local schools and asked who the best contact was to address this? General discussion ensued regarding the issue.

### **Committee Reports:**

- i. **Project Manager Report** Myra reported: Business membership—Visited the new Koolberry & Everytable, took photos and shared the news of their opening through social media and email list; attended the grand opening of Laserfiche's new building; Rad Coffee will be opening next week; Social Media features-completed our Women of Bixby Knolls profiles, took 7 weeks to do so; also promoting Easter weekend specials; working on our Business Breakfast/Annual Meeting preparations; sent 8 emails to members last month; Huge turnout for First Fridays "County Fair" theme, with pre-pandemic attendance numbers; Knights returns to the Pan on April 28, Blair will MC the session; taking a Spring Break for Kidical Mass in April, back in May for the 10<sup>th</sup> anniversary; Myra provided social media follower updates.
- ii. **Security & Code Enforcement** Included in E.D. Report Some local residents would like to partner with the BKBIA to pool resources and pay for additional security patrols in the district and neighborhoods. A meeting will be set to discuss this further.
- iii. Executive Director Report Blair reported: 1st amendment issues—First Fridays has the candidates for the upcoming election setting up tables, we do not have a problem with this as long as it doesn't interfere with any business; there was a negative post recently by an employee of a business, could be considered "hate speak" and we were asked if the BKBIA would make a statement. There is a difference between one person's opinion (1st amendment right) vs. a business making a statement and the BKBIA taking a stand about this. (General discussion ensued); Candidate forum will be held at Expo on Monday, April 25, 6pm. Board reviewed Annual Meeting outline of topics to be shared with membership on April 28; Commune Communication is creating collateral material for soliciting First Fridays and Security sponsorships; BKBIA received first \$50K of the "bridge funding" to help cover the costs of Commune's work and additional consultants like Ines Torres and Jayro Sandoval.

# Safety/Security issues –

- o Freddie w/CSI to report and give updates
- o Don & Harold's vandalism (Details will be read from email)
- O Street issues: As mentioned in previous meetings, we see the increase in mental illness of individuals around the district, often times causing disturbances to businesses and/or damage to the area. Recently, all trashcans on Atlantic were moved into the street. This was a potential disaster waiting to happen since all the cans were full and overloaded. The challenge continues: budget vs. the need to have a greater presence from CSI. We will continue to deal with these issues as best as possible.

# • BK Community Foundation status

- o John Glaza helped to facilitate a board meeting of the BKCF board members. There were parliamentary issues to get caught up with.
- John provided the minutes of the meeting for our records and engaged all current members. Aaron Hovis was elected as President of the Foundation.
- o The next meeting is scheduled for June and we will address the recruitment of new members, goals for fundraising, and the issue of being a fiscal receiver for other non-profits.

# • Accounting status

Susan Cooper, who has been our bookkeeper for many, many years had an extra challenging tax season this year. As a result, we may need some extra help in inputting all of our payables into Quick Books to get us current. Susan will return from vacation in another week or so and come back to lend a hand, but it may be a good idea to hire someone in the meantime to get things caught up. Susan can then run reports for us to share with the board. We always appreciate Susan's work for the BKBIA and recognize that sometimes people need a break so we want to lessen the burden here while making sure we are always current in our accounting.

# **Status of American Recovery Act Grant Funds**

- We heard from Economic Development this week that our application and Scope of Work has been approved. The city attorney is drafting the management agreement with the BKBIA for these funds and we should receive 50% (approximately \$68,000).
- A reporting template will be issued to all BIDs to provide all required information (receipts, invoices, names of businesses) back to the city to make sure we are in compliance with the federal guidelines.

# Status on progress for pursuing revenue streams

# • Sponsorship collateral material

 Commune Communication has completed the documents and the files are ready for printing and distribution. This information can also be emailed to potential sponsors. We can share all of this with the board immediately.

# • District expansion status

• Efforts for the expansion are on hold at the moment until we pursue the two other options.

## • Assessment increase collateral material

Our cover letter to accompany the pamphlet had to be revised and we have resubmitted it for one last review. It was important that the message was clear that the BKBIA was pursuing new revenue streams and wasn't being dictated to by the city to impose more taxes on our businesses.
